We, to the best of our knowledge, hereby confirm that all PUMA products are in accordance with Proposition 65. Chemicals in our products are not regulated under Proposition 65 or are in amounts that would not require a warning label.

PUMA has implemented a Restricted Substances List for all its products. This list defines restrictions for harmful substances that guarantee compliance with legislation, defines even stricter requirements for many substances and is updated on a regularly level. The test results are continuously reported to PUMA. This ensures that we can control that PUMA products do not contain substances of high concern and fulfill PUMA product safety standards.
